## CRIME IN JAMAI


In its continuing efforts to maintain law and order in our country the PSOJ again met with the Prime Minister and the Leader of the Opposition on February 1, at Vale Royal. The purpose of this meeting was to discuss the nation's crime problems and to review the sixteen recommendations in the report of the National Committee on Crime and Violence prepared last October.

Emerging from this meeting was a commitment from both leaders to make the upcoming general elections "the most peaceful in the history of Jamaica", an agreement to appoint an Acting Political Ombudsman and the commissioning of a study on the Drug Industry in Jamaica. A report on the decisions taken at this meeting will be prepared and made public in due course.

This meeting took place after the January 16th announcement by the new Minister of National Security, Dr. Peter Phillips of a 12-point Crime Fighting Plan and the announcement of a 4pronged crime fighting strategy by the Jamaica Labour Party (JLP) the day before.

Dr. Phillips' 12-point plan includes Border Control, Intelligence Gathering, Increasing Manpower of the security forces, Re-organizing the Jamaica Constabulary Force (JCF) Crime Fighting Capabilities, Stiffer Firearm Penalties, Restoration of Public Order, Peace Management, Police Public Complaints and the Well-being of the Security Forces.

The JLP's 4-pronged plan includes Independence of the Police Services Commission, Effective Intelligence Gathering, Infrastructure Improvement and Intensified Penalties for acts of terrorism and other atrocities.

These meetings and plans to combat crime came as a result of the high level of crime in particular murder that Jamaicans have experienced since last year. Crime statistics for last year show murders increasing by 28% to 1,139, shootings by 17% to 1,183, and rapes by 5% to 912.

The New Year began with violent killings in Park Lane and 100 Lane areas of Red Hills Road resulting in concern among citizens for potentially high crime levels during this election year. Crime statistics for the period January 1st to February 10th show a total of 106 murders compared with 98 for the same period last year. Four parishes namely, St. Thomas, Trelawny, St. Mary and Portland have had no reports of murders for this period.

The motives for these 106 murders have been Seventy-five percent (75%) of shootings in 2001 classified in the main as Reprisals, Domestic and occurred in the Kingston Metropolitan Area. For the period 1997-2001 major crimes

Declined from a total of 12,691 to 8,061. This overall decline is attributed to the cumulative effect of a decline in robbery, break-in, larceny and carnal abuse for this period. Murder, shooting and rape on the other hand have fluctuated for this period. They all declined during the period 1997 to 1999 and have increased since 2000.

In 2001, 14% of all major crimes were murders, 15% shootings and 11% rapes.

In the case of murder, 93% of the motives were classified as reprisals, domestic, drug/gang related, and robbery. The gun and the knife were the main implements used; the gun being used 69% of the time and the knife 18% of the time.

Murders cleared up in 2001 were 42% compared to 61% in 1999. With regards to firearm recovery, 2,521 have been recovered since 1997 averaging 504 per year.
