PHILLIP PAULWELL President, JCTC Staff Association, 1989-1990

Phillip Paulwell is a member of JCTC's Legal team. He received his LL.B. at the U.W.I. in 1986; and his legal education certificate from the Norman Manley Law School in September 1988. He was called to the bar as a practising attorney-at-law in November 1988.

Since joining JCTC in 1988, Phillip Paulwell has gained a reputation for getting involved in just about every area of company activities.



Last year, Phillip's interest in staff affairs became official. He was elected President of the JCTC Staff Association in November 1989.

In his high school days, Phillip had been active in student activities, serving as President of the Students' Council and as Head Boy at Excelsior. At the UWI, he was President of the Law Society and the Jamaica Association of Students at Cave Hill, Barbados.

So, Phillip is quite correct when he says that filling a leadership role is not strange to him. "I regard myself as the mouthpiece of others and as such I oftentimes play a representational role," he says.

For the rest of his term as President, Phillip will focus on increasing the level of staff morale. "My major focus will be to devise a plan for using company pension funds to provide mortgage facilities for staff. All of us want to own our home, he says, and achievement in this area will help staff to feel better about themselves and the Company.

"I believe that staff associations should concentrate on other things besides negotiating increases in salaries. They should spread their area of influence to cover staff training, codes of conduct, increased social interaction, participation in sporting competitions outside the company and other types of innovative benefits."

SYLVIA BOGLE Secretary, JCTC Staff Association, 1989-1990



K.I.W. WAREHOUSE Working There Can Be Hectic

From time to time, the government-owned Jamaica Commodity Trading Company engages itself in barter trading agreements. One such trading agreement took place when Jamaica traded bauxite for Yugoslavian hardware materials.

JCTC was given the role of pricing the goods (at a subsidised rate) and selling these to the public.

With this added responsibility the JCTC had to locate a warehouse to store and deliver all these commodities which included, for example, chipboard, blockboard. masonite (plain and perforated), wall tiles, cement, plyboard and kitchen sinks.

In 1985, the JCTC leased as their warehouse a section of the K.I.W. Hardware Limited Complex located at 138 Spanish Town Road.

Pete Smith is the Supervisor of this warehouse. He listed his main duties as:

- (1) ensuring that customers get the goods they have paid for, after they're presented with the relevant documents (orders) issued from the JCTC's head office:
- providing a regular stock inventory of hardware materials, zinc, rejected and damaged lumber.

Mr. Smith supervises a staff of 16 casual employees. He finds the job challenging, because, "Ihave to deal with all types of people (customers) and even my own co-workers who at times make the job hectic." He went on to add that there is 'hardly any time to

be bored, but regrets that the location of the place is so isolated. Because of this, he and the others sometimes tend to feel locked off from the outside world, and they're not even aware of what's taking place at the head office. He admits that the radio system and telephone help, but at times, "They both prove ineffective in communicating urgent and sometimes sensitive information to my supervisors at the office.

The hardworking casual staff at the KIW warehouse also played an integral role in putting the nation back on its feet after the destruction caused by Hurricane Gillbert. This warehouse housed and delivered a vast amount of hurricane relief items.

The views and opinions of a few of the staff members of the warehouse are expressed below.



Warren McKenzie, Lumber Clerk

'I'm a lumber marker and I help to deliver lumber and other goods. I've been employed with the Company for 7-8 years and I have a lot of experience on and off the wharves. I know lumber very well (size and lenath). Hove my job and I wouldn't change it for anything. If I did I would have to be going into my own business and it would have to be in lumber."

Glenford Ricardo Campbell, Lumber Clerk

"I've only been employed with the Company for one year and a few monts. I like the job; as a matter of fact, I love to work, it comes in like a hobby to me. I also love maths and since the job

entails a lot of this, it makes the job fulfilling. I respect the Company and my co-workers and we live as a family even though we sometimes have conflicts ... but that's life.'

"I find the job ok . . . I come expecting to do a day's work. I'd however like to see the staff at the office give us more credit, because we do a lot of hard work out here, under adverse conditions. 
Michael Martin, Acting Managing Director

INTERNAL AUDIT

The Internal Audit Department was ushered into existence as a full-fledged independent entity in 1980, as part of the JCTC family. Though its profile in comparison to other departments might seem lowkeyed, one can't help but noticing its eyes roving over the entire operations of the Company. And so, while it functions behind the scenes, its effectiveness can be attested to by most of us in JCTC who at one time or another come within its watchful eyes.

The department functions basically as the "eyes" and "ears" of management. It seeks to ensure that all our activities are above board and are properly executed. It tries to guarantee that all the features of sound and proper management are maintained. It has assisted in instituting effective control mechanisms, and also in devising methods and systems of improving the company's efficiency.

The department is also responsible for maintaining adherence to the Company's policies and for due recognition to be given to the principles of accountability and fairplay.

Its day-to-day functions include the verification of assets by independently checking existing stock and inventory, bank reconciliations, constant observation of our tender process, and ensuring proper and accurate purchasing, marketing and accounting operations. It also investigates matters which are potentially harmful to the company's interests.

As an adjunct to the M.D.'s Division, Internal Audit interfaces with every department in the Company. It also maintains a strong link with our external auditors and plays a leading role on the Company's audit committee.

Mr. Joe Wilks is our chief inter-

nal auditor (a.k.a. C.I.A.) and the head of the department. He prides his department with being totally independent in its assessments and recommendations. Mr. Wilks and his staff are firmly committed to the JCTC concept; and in Mr. Wilks' own words, "I am a people person and I see the role of the Com-
