

PUBLIC SAFETY MONITORING COMMITTEE

COMMUNIQUE 1

The Private Sector Organisation of Jamaica (PSOJ) has partnered with the Ministry of National Security to produce a Quarterly Communiqué with updates to the PSOJ network and general public on developments in the area of citizen security. On July 31, 2020, a Memorandum of Understanding was signed between the PSOJ and Ministry of National Security (MNS) to monitor and govern the arrangements for these initiatives. The information contained in this report is up to the period ending September 30, 2020.

Public Safety Programmes/Projects/Initiatives

The information on public order/ public safety being monitored include:

- 1. Traffic Ticket Management System (TTMS)
- 2. National Surveillance Programme Jamaica Eye Project
- 3. Road Safety
- 4. Noise Abatement Regulations

TRAFFIC TICKET MANAGEMENT SYSTEM (TTMS)

The Traffic Ticket Management System (TTMS) is a centralised, web-based system, accessible island-wide via the Internet and allows stakeholders secure, segregated access to the traffic ticketing data. The TTMS has the capability to match tickets with payments, record details of court decisions and manage demerit points.

The TTMS therefore manages all traffic tickets from entry to closure. The locations currently using the TTMS encompass fifteen (15) Data Entry locations, Parish Courts, the Island Traffic Authority and the Ministry of National Security.

NATIONAL SURVEILLANCE PROGRAMME - JAMAICAEYE PROJECT

JamaicaEye is an island-wide network of camera surveillance systems designed to increase the safety of all citizens and improve public order. The JamaicaEye Programme, which was officially launched on March 14, 2018, is aimed at:

- a. Integrating the existing GoJ camera systems, which are currently in the towns of May Pen, Mandeville, Negril, Montego Bay and Ocho Rios to operate as a single National Surveillance System.
- b. Collaborating with other stakeholder agencies, in executing a three (3) year implementation plan, of installing additional cameras in the aforementioned locations as well as other critical areas across the island.
- c. Designing an operational framework to monitor public spaces across the island and assist the authorities to strategically respond in the event of disasters, acts of criminality and accidents.

ROAD SAFETY

Road Safety, specifically fatal collisions and fatalities among motorcyclists, and general improvements in road safety achieved through targeted enforcement by the Jamaica Constabulary Force (JCF), are the current areas for monitoring and reporting. In 2019, there was a total of four hundred and forty (440) road fatalities. Road fatalities have increased by thirteen per cent (13%) when compared with the corresponding period in 2018, which recorded a total of three hundred and eighty-nine (389) road fatalities. The total figure for road motorcycle fatalities for 2019 was one hundred and thirty-three (133). This represents a thirty-three percent (33%) increase when compared to 2018, which recorded one hundred (100) fatalities.

NOISE ABATEMENT REGULATIONS

The Noise Abatement Act is legislation that guides noise nuisances. The Ministry of National Security technical team will hold consultations with the relevant stakeholder groups in order to establish agreements within the context of the Act to reduce noise nuisances.
